

Terms and Conditions

The World Outside HAF Holiday Club

By booking a place, I confirm that I am the parent/guardian of the named child(ren) and consent to their participation in this Forest School holiday club.

I acknowledge that:

- I have read, understood, and agree to these terms and conditions.
- The holiday club takes place in a **woodland setting**, and children will be outdoors for the **entire session**, regardless of weather.

Safety and Supervision

- Forest School activities involve a degree of managed risk and physical activity, including getting muddy and using tools under supervision. These activities are fully risk-assessed and led by qualified staff.
- Sessions are child-led and inclusive, with staff holding enhanced DBS checks and up-to-date first aid training.
- Due to our location which is on the premises of a Kindergarten. no parent will be allowed access or allowed to accompany their child on to site.

Medical and Emergency Care

- I confirm that there are no medical reasons why my child should not participate.
- If my child has asthma, **they must bring their inhaler**, or they will not be permitted to take part.
- If my child has a severe allergy that requires an **EpiPen**, **they must attend** with it or they will not be permitted to join the session.
- I consent to any emergency treatment necessary and authorise staff from The World Outside to act in loco parentis should emergency medical care be required. Every effort will be made to contact the named emergency contact.
- I will provide **accurate emergency contact details** that will be reachable during the session.



Clothing and Equipment

- I understand that children must wear **appropriate outdoor clothing**, including:
 - Long-sleeved tops, trousers, and sturdy footwear (e.g., wellies or walking boots)
 - $_{\odot}\mbox{Waterproof}$ coats and trousers
- Crocs, sandals, and open-toed shoes are not permitted. Children arriving without appropriate footwear or clothing may be excluded for safety reasons.
- Children should bring all belongings in a **clearly labelled**, **self-contained bag** that they can carry themselves.

Food, Allergies, and Medication

- All allergies, medical conditions, dietary needs, and intolerances must be communicated to The World Outside at least 48 hours before the session.
- All medication must be provided in a **clearly labelled container**, with the child's name, dosage instructions, and administration time.

Arrival Time and Access

Due to the nature of the woodland setting, we are **unable to return to the gate once the group has entered the woods**.

- Drop-off is strictly no later than 8:55am.
- The group will leave the entrance promptly at **9:00am**, and **no access will be** available for late arrivals.
- It is the parent/guardian's responsibility to ensure timely drop-off and collection.

Additional Needs

If your child has additional needs that may require 1:1 support, please contact Sandra on **07765 394456** before booking, so we can assess whether the provision is suitable and safe for them.

No-Show and Cancellation Policy

If a place is booked and the child does not attend **without prior notice or cancellation**, any **future bookings will be cancelled**. Parents are welcome to rebook if space allows, but this policy ensures that valuable places are made available to children who wish to attend and benefit from the programme. Please inform us as soon as possible if your child is unable to attend a session.



Final Agreement

By submitting a booking, I confirm that all information provided is accurate, and I agree to the terms outlined above, including attendance expectations, safety policies, and clothing/medication requirements.

What Your Child Needs to Bring:

- Refillable water bottle
- Sturdy shoes or wellies (no Crocs or open-toed shoes)
- Waterproof coat and trousers
- Sun cream (pre-applied if needed)
- Insect repellent
- Required medication (e.g. inhalers, EpiPens)
- All belongings in a **self-contained backpack** your child can carry independently
